### Food Vendor Contract

LOCATION: Colonial Beach Town Hill (at the corner of Colonial and Washington Avenues)

EVENT DATES: December 6, 2025

TIMES: 12:00pm – 4:00pm

FEES: \$66 per each 10' x 10' space

\$15 additional per space for electric

#### RULES:

1. **Contracts are due by November 21, 2025 and must include the completed and signed contract with payment.**
2. A valid Virginia Department of Health (VDH) food permit must be displayed. Contact the Virginia's Food Safety Program, 804-864-7473 or [FoodSafety@vdh.virginia.gov](mailto:FoodSafety@vdh.virginia.gov) for additional information.
3. Contracts received after November 21, 2025 will be charged an additional \$20.
4. A \$30 fee will be charged for all returned checks.
5. One vendor per space. Vendor or proxy must host display.
6. It is required that all vendors will stay for the entire festival.
7. All work must be priced.
8. Spaces must be set up by 11:00am. You may arrive as early as 9:00am on December 6.
9. No vehicles will be allowed on Town Hill except for loading and unloading.
10. Confirmation provided upon receipt of contract/payment.
11. The entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
12. This event takes place Rain or Shine.
13. By signing the contract to participate as a vendor, all parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
14. The Winter Festival Committee/Chamber of Commerce Staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
15. Please understand, there will be no "off-sides" vending without prior permission.
16. Vendors **MUST** park away from Town Hill after unloading your vehicle.
17. Vendors are responsible for their own trash removal.
18. If you anticipate sales over \$15,000.00, please contact the Town of Colonial Beach at 804-224-7181 to obtain a business license.
