LOCATION: Colonial Beach Town Hill (Colonial Avenue and Washington Avenue)

EVENT DATES: September 12-13, 2026

10:00am - 4:00pm Sunday

FEES: \$165 per 10' x 10' space – includes both days

RULES:

1. **Contracts are due August 15, 2026 and must include the completed and signed contract with payment.**
2. **Contracts received after August 15, 2026 will be charged an additional \$20.**
3. A \$30 fee will be charged for all returned checks.
4. One vendor per space. Vendor or proxy must host display.
5. It is required that all vendors will stay for the entire festival.
6. Spaces must be set up by 10:00 am. You may arrive as early as 8 am on September 12th for set up.
7. No vehicles will be allowed on the Boardwalk except for loading and unloading.
8. Confirmation provided upon receipt of Contract/payment.
9. Entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
10. This event takes place Rain or Shine.
11. By signing the Contract to participate as a vendor in the Annual Northern Neck Beach Music Festival, parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
12. The Northern Neck Beach Music Festival Committee/Chamber of Commerce Staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
13. Please understand, there will be no "off-sides" vending without prior permission.
14. There are no electrical hook ups available. Please bring your own generator if needed.
15. Vendors are responsible for their own trash.
16. This is a non-juried event.
