LOCATION: Colonial Beach Town Hill (Colonial Avenue and Washington Avenue)

EVENT DATES: September 12-13, 2026

TIMES: 10:00 am - 5:00 pm (Saturday)
10:00 am - 4:00 pm (Sunday)

FEES: \$165 per each 10' x 10' space (includes both days)

RULES:

- 1. Contracts are due by August 15, 2026, and must include the completed and signed contract with payment.**
- A valid Virginia Department of Health (VDH) food permit must be displayed. Contact the Virginia's Food Safety Program, 804-864-7473 or FoodSafety@vdh.virginia.gov for additional information
- 3. Contracts received after August 15, 2026, will be charged an additional \$20.**
- A \$30 fee will be charged for all returned checks.
- Vendors are required to stay for the entire festival.
- One vendor per space. Vendor or proxy must host display.
- Spaces must be set up by 10:00 am. You may arrive as early as 8 am on September 12th for set up.
- No vehicles will be allowed on the Boardwalk except for loading and unloading.
- Confirmation provided upon receipt of contract/payment.
- The entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
- This event takes place Rain or Shine.
- By signing the contract to participate as a vendor, all parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
- The Northern Neck Beach Music Festival Committee/Chamber of Commerce staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
- Please understand, there will be no "off-sides" vending without prior permission.
- There are no electrical hook ups available. Please bring your own generator if needed.
- Vendors are responsible for their own trash removal.
- If you anticipate sales over \$15,000.00, please contact the Town of Colonial Beach at 804-224-7181 to obtain a business license.
